

# TOWN OF ATHELSTANE, MARINETTE COUNTY WI. 2010-2011 SNOWPLOW CONTRACT

It is hereby agreed by and between the Town of Athelstane of Marinette County, Wisconsin, herein after named the "Town", and the "Driveway Owner/Private Road Coordinator" WHEREAS, the driveway owner/private road coordinator desires to obtain snowplowing services for driveways/private roads within the Town of Athelstane, and WHEREAS, the Town of Athelstane provides for snowplowing services for driveways/private roads in the Town of Athelstane.

NOW, THEREFORE, the parties agree as follows:

1. The driveway owner/private road coordinator agrees to pay the Town for the service of snowplowing the driveways/roads of the owner/coordinator as follows:

- A. A fee of \$150.00 per season for driveway/road lengths of Zero to 150 feet long.
- B. A fee of \$200.00 per season for driveway/road lengths of 150' to 900' long.
- C. A fee of \$250.00 per season for driveway/road lengths of 900' to 2,900' long.
- D. A fee of \$250.00 per season for driveway/road lengths of 2,900' long PLUS an ADDITIONAL \$75.00 EACH ¼ MILE over 2,900' (528 Feet In 1/10 of a mile)  
NOTE: There are 1320 Feet in ¼ mile.

On Private Roads, residents must assign someone to be the road coordinator, collector and control person and be listed on the contract being returned. See second sheet.

## **NEW PAYMENT OPTIONS AVAILABLE FOR 2009-2010 PLOWING SEASON**

A full payment for plowing services will be due on September 15th, 2010.

A 50% First installment option is available and will be due September 15th, 2010.

A 50% and final paid in full option will be due January 1, 2011. If the final payment is not received by January 1, NO PLOWING WILL BE DONE FOR THE REST OF SEASON.

All payments MUST be accompanied by this contract signed by the driveway owner/road coordinator, Town Chairman and Town Clerk.

2. The driveway owner/road coordinator agrees to hold the Town and County harmless from any and all claims made from injuries or damages by the driveway/coordinator, agents, or employees of the owner/coordinator, assigns or heirs of the owner/coordinator, against the Town arising out of snowplowing private drives/private roads and property.

3. The driveway owner/road coordinator further agree to all snowplowing regulations for private drives/roads now in effect within the Town. (See second page)

4. Driveway owner's FIRE NUMBERS are to be used for identification AND SIGNS MUST BE CLEARED OF ALL OBSTRUCTIONS AND VISIBLE UPON VIEWING!

## SNOWPLOWING REGULATIONS

Snowplowing of all private drives/private roads will be done AFTER ALL TOWN ROADS have been plowed. HOWEVER, IF THERE ARE SPECIAL MEDICAL NEEDS THAT REQUIRE HEALTH & WELFARE ATTENTION, CALL THE TOWN CLERK TO SCHEDULE SPECIAL PLOWING NEEDS.

Plowing will start December 1<sup>st</sup>, providing the ground is frozen and the plowing will end on March 1<sup>st</sup> as the frost starts to come out of the ground.

1. Driveways must be a minimum of twenty (20) feet wide with adequate space for plow to turn around.
2. The minimum height clearance must be fifteen (15) feet.
3. The driveway must be free of any and all obstructions, (trees, stumps, boulders, etc.,) which would prevent entrance of the snowplow onto the drive/road.
  - A. Any unmovable objects must be marked with a four (4) foot painted stake.
  - B. If obstructions are present, the driveway will NOT be plowed

The Driveway owner MUST make arrangements with someone other than the snowplow driver to have gates, chains, poles, etc. opened or removed to allow access to the driveway. Owner must also provide for the closing of such drives if required. THERE WILL BE NO EXCEPTIONS!

**ALL DRIVES/PRIVATE ROADS WILL BE QUALITY CHECKED & MEASURED FOR COMPLIANCE BEFORE THE AGREEMENT WILL BE ACCEPTED!!**

**You will be notified within 10 days or sooner (after receipt of your contract & check), if the inspection shows non-compliance or length difficulties.**

NOTE: There are 528 Feet in a tenth of a mile on your odometer.  
There are 1320 Feet in a ¼ of a mile.
