Resolution to Adopt the
Town of Athelstane
Year 2030 Comprehensive Plan
Marinette County, Wisconsin
Ordinance # 27

The Town Board of Athelstane does hereby adopt the following:

1. WHEREAS, Pursuant to Sections 62.23(2) and (3) for cities and villages, and for towns exercising village powers under 60.22(3) of the Wisconsin Statutes, the Town of Athelstane is authorized to prepare and adopt a comprehensive plan as defined in Sections 66.1001(1) (a) and 66.1001(2) of the Wisconsin Statutes; and

2. WHEREAS, the Athelstane Town Board has committed resources and funding to develop a Comprehensive Plan in conjunction with a Wisconsin Department of Administration Comprehensive Planning Grant; and

3. WHEREAS, the Town of Athelstane worked cooperatively with the towns of Amberg and Silver Cliff to cooperatively develop the Athelstane Year 2030 Comprehensive Plan in order to guide and coordinate land use decisions and development in the town; and

4. WHEREAS, the Athelstane Year 2030 Comprehensive Plan has been prepared in cooperation with the Town of Athelstane Planning Committee, Athelstane Town Board, residents and property owners, Foth and Van Dyke, Planning Consultants, Marinette County University of Wisconsin-Extension , Land Information and Zoning Departments, the Bay-Lake Regional Planning Commission, and the Wisconsin Departments of Transportation , Natural Resources, and Administration; and

5. WHEREAS, numerous public meetings and mailings have been facilitated in conjunction with a public participation plan, town goals, public opinion and participation, including an Issues Workshop held October 14, 2003, public informational meetings held on October 14, 2003 and June 19, 2004, direct mail postcard notifications sent to all property owners preceding the June 19, 2004 public informational meeting and October 23, 2004 public hearing. The public hearing was preceded by a class I notice and widespread comprehensive plan document distribution in accordance with Wisconsin Statutes 66.1001(4) to facilitate plan access and to gather public comments.

6. NOW THEREFORE, BE IT RESOLVED, that the Town of Athelstane Plan Commission hereby recommends to the Town of Athelstane Board of Supervisors the adoption of the document entitled “TOWN OF ATHELSTANE YEAR 2030 COMPREHENSIVE PLAN” Marinette County, Wisconsin as the Town of Athelstane’s comprehensive plan according to Sec. 66.1001(2) of the Wisconsin Statutes.

7. BE IT FURTHER RESOLVED, the Town of Athelstane Plan Commission recommends that the town pursue necessary and reasonable action to implement the primary directives and recommendations of the Year 2030 Comprehensive Plan as noted therein.
